## **CONDITIONS OF TRANSFER OF REGISTRATION**

- a) The animal is to be inspected and approved for transfer by two persons appointed for the purpose by the Manager of Business Development.**
- b) If the animal is not identified by tattoo, it is to be tattooed with stud prefix, year of birth and a unique within-herd number by the owner and recorded on the Application to Transfer Registration as such.**
- c) A certificate of DNA parentage verification of the animal and a dry, clean follicle sample in an envelope clearly marked with the bull's tattoo identification , must be provided to Shorthorn Beef.**
- d) The owner of the bull must be a full financial member of Shorthorn Beef.**
- e) A classification fee of \$550 (inclusive of GST) for each bull and \$22 (inclusive of GST) for each female is to be forwarded with the record of inspection to Shorthorn Beef.**
- f) Shorthorn Beef retains the right to refuse the Application to Transfer Registration for any reason and no correspondence shall be entered into.**
- g) A certificate identifying the animal as being Herd Book Registered shall be issued by Shorthorn Beef.**
- h) The suffix HBR shall be affixed to the animal's identification on a certificate of registration.**
- i) All costs associated with inspection of the animal shall be paid for by the applicant.**
