Please find enclosed Entry Form, Conditions of Entry and important notices regarding the 30th NSW Shorthorns Spring Fling Bull Sale, as outlined below.

CLOSING DATE 31 MAY 2019

- **Spring Fling Subcommittee is coordinating the sale.**
- **Date:** The 2019 NSW Shorthorn Spring Fling Bull sale will be held Thursday 25 July 2019, 1.00pm at the Tamworth Regional Livestock Exchange.
- **Stalling:** Stalling of bulls will be at Tamworth Regional Livestock Facility **All bulls to be at the TRLX by 2.00 pm Wednesday 24 July 2019.**
- **Inspection:** Weighing & scanning of bulls will commence at the TRLX at a time to be advised.
- **Vet Inspection: Vendors to arrange vet check from 14th June 2019 onwards. Certificate to be provided, must include testicle measurement.**
- **Agents:** Elders Rural Services is the sole selling agent.
- **Agents Rebate:** Outside agent's rebate of 5% is to be offered by all vendors. See condition 22 on entry form.
- **Sale order:** Determined by previous years sale average on bulls offered. Subject to committee discretion Maximum run of 4, offer 3 bulls gets one run, 4 bulls offered goes in 2 runs. New vendors go in at end of first run, order determined by draw of hat. New vendors & returning vendors restricted to 2 bulls. **(See Condition of entry 4b.)**
- **Advertising:** Spring Fling ran a very successful Print & TV advertising program last year. The separate Spring Fling feature in The Land along with a campaign run by Struan & Monika Pearce of studstocksales.com was a success and we seek your valued support again to ensure maximum exposure for the sale. **The sale was also listed with AuctionsPlus which the committee deemed to be worthwhile, this will continue in 2019.**
- **Entry Fee: has been increased to \$300/head to reflect the rising costs.**
- **Administration:** Please ensure copy of Certificate of Currency for Public liability Insurance accompanies entry forms
- All relevant Vendor Declarations, Health papers etc. are completed correctly.
- **Vendor's responsibility to confirm entries were received by sale coordinator.**
